Hidden Waters at Buttercup Ranch & Creamery (aka Suus Donum Enterprises, Inc. DBA Buttercup Ranch & Creamery) shall be referred to hereinafter as Buttercup Ranch & Creamery.

The above renters shall be referred to collectively hereinafter as Renter(s). Each of the renters are jointly and severally responsible for the obligations contained in this Agreement. As the Renter(s), you are the host of the event.

Down Payment: A 50% non-refundable down payment is required to hold your date. The balance plus a \$400 security deposit is due 30 days prior to the event. Your security deposit is fully refundable if there is no damage or loss to the premises.

Event Liability Insurance: A "Certificate of Liability Insurance" which names "Suus Donum Enterprises, Inc. DBA Buttercup Ranch & Creamery" is required. This is a one-day (set up, ceremony, reception, tear down, and 48 hours before for rehearsal) endorsement for bodily injury and property damage in the amount of \$1 million. The certificate must also show the date(s) of the event and the name of the rental party. We recommend Markel Insurance (800-236-2453).

Food & Alcohol: You may bring in your own food and/or catering. You or your caterer will be responsible for supplies, dishware, and utensils. If alcohol is present at your event, a classification for this must be added to your Certificate of Liability Insurance (talk to your insurance provider). You or bartender must also supply cups and glassware.

Duration of Event: One day events start at 10 am and end at 8 am the next day. Weekend events start at 10 am on Friday and end at 10 am on Monday. You must be cleaned up and out by the end time. There will be a late fee of \$75 per hour (the first 30 minutes after your end time will not be charged, but any part of that hour after 30 minutes that you are still on the premises, you will be charged the full hour).

<u>Supervision of children</u>: If small children will attend your event, we strongly recommend you designate someone to look after them. Children must be supervised at all times. Buttercup Ranch & Creamery is not responsible for unattended children.

<u>Noise Levels</u>: No person shall make, assist in making, permit or allow to continue any unreasonable noise between the hours of 11 pm to 6 am. Please help us to consistently minimize the noise levels by informing your event party of the noise ordinance before your event.

<u>Prohibitions:</u> No firearms, cannabis or illegal drugs may be used or possessed on or around Buttercup Ranch & Creamery.

<u>Clean-Up, Lost & Abandoned Items:</u> You are responsible to dispose of all trash upon completion of your event. A dumpster in front of 5867 Floraville Road is available to dispose of trash. Please take away all your belongings. Buttercup Ranch & Creamery will put tables away. Please keep all your valuables with you at all times. We are not responsible for any stolen items.

<u>Refunds/Cancellation:</u> No refunds will be given if you use less than your purchased hours on the event date. If your event is cancelled for any reason, Buttercup Ranch & Creamery will refund the \$400 security deposit.

Damages: You will be responsible for any damage to any structures or rented items used by you at Buttercup Ranch & Creamery for your event. Any material you bring in to toss at the wedding party must be biodegradable.
